OF

AND WE HEREBY CERTIFY:

First. That the name of said Corporation is The "SUGAR CITY PHARMACY" "Limited."

Second. That the purposes for which it is formed are To conduct a general drug business in all its branches, and own and lease real estate necessary to carry on such business.

Third. That the place where its principal business is to be transacted shall be Sugar City, Fremont County, Idaho.

Fourth. That the term for which it is to exist is twenty-five (25) years from and after the date of its incorporation.
