## ARTICLES OF INCORPORATION

OF SHAFT, INC. SET 16 1 14 PH '88 SECRETARY OF STATE

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned, being natural persons of full age, citizens of the United States and residents of the State of Idaho, this day have voluntarily \$5586|\$100 ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

## ARTICLE I.

The name of this corporation shall be SHAFT, INC.

## ARTICLE II.

The existence of this corporation shall be perpetual.

## ARTICLE III.

The principal office or place of business of this corporation shall be at 722 E. Second Street in Meridian, Ada County, Idaho; but the corporation may maintain an office in such towns, cities, or places inside or outside the State of Idaho as the Board of Directors may from time to time determine, or as may be designated by the By-Laws of said corporation. The registered agent shall be LYNNA K. SEARCH, 3870 Carbondale, Meridian, Idaho 83642

## ARTICLE IV.

The purpose for which this corporation is organized is to include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

## ARTICLE V.

The total amount of capital stock of this corporation is fifteen thousand dollars (\$15,000), and the number of shares into which it is divided is fifteen thousand (15,000) of the par value of one dollar (\$1.00) each. Of this total capital stock, fifteen thousand shares (15,000) of the aggregate value of fifteen thousand dollars (\$15,000) are common stock. No preferred stock

will be claimed or issued.

#### ARTICLE VI.

The members of the governing board of this corporation shall be styled "Directors", and the Board of Directors shall consist of not less than one (1) nor more than seven (7) members, as may be provided by the By-Laws of the corporation.
