ARTICLE I
NAME

Prior to the effective date of these Articles of Amendment, the name of the Corporation was Guardian Northwest Insurance Agency, Inc.

ARTICLE II
AMENDMENT ADOPTED

The following amendment to the Restated Articles of Incorporation was adopted by the Corporation in the manner prescribed by the Idaho Business Corporation Act:
