ARTICLES OF INCORPORATION

OF

ALLIED ROOFING AND INSULATION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: NAME

The name of the corporation is Allied Roofing and Insulation, Inc.

SECOND: DURATION

The period of its duration is perpetual.

THIRD: PURPOSE

The purpose or purposes for which the corporation is organized are: for the purchase, sale and installation of insulation and roofing materials, at wholesale and retail, and all other items, materials and labor incident thereto, and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: SHARES

It shall have the authority to issue 1,000 shares of stock, all of one class, of \$100.00 par value.
