



ARTICLES OF INCORPORATION

ARTICLE 1

The Name of the corporation shall be THE BIBLICAL CHURCH OF GOD.

#### ARTICLE II

- A. THE BIBLICAL CHURCH OF GOD is organized according to the biblical principles found in the Bible, and outlined in the Constitution and Bylaws. The purpose of the Church is to serve the people of God. To teach all people to love God, with all their hearts, with all their minds, with all their strength; and to love their neighbor as themselves; to carry on a work of God to warn this world of the impending deception of Satan on this world, to preach a message of repentance, reconciliation, and God's love, and help prepare the way for the return of our Lord and Saviour Jesus Christ; to help any whom God is calling, to repentance, to baptism and the acceptance of Jesus Christ as personal Saviour and accept the blood of His sacrifice for the forgiveness of sins: to help any who desires to grow in grace and knowledge of Jesus Christ and the Spirit of God the Father.
- B. THE BIBLICAL CHURCH OF GOD, to fulfill its purpose of proclaiming the truth of the Bible to all people, will have a division of evangelistic media called BIBLE ANSWERS. The Church and BIBLE ANSWERS are dedicated to proclaiming the Truth of The Bible through evangelistic preaching, and teaching on radio, television, the printed word, and cassette lessons, for all who would hear and desire to find the biblical answers to their life situations. The motto of BIBLE ANSWERS is "Man shall live by every word of God".

- C. THE BIBLICAL CHURCH OF GOD is to have and exercise all rights and powers conferred on non-profit corporations under the laws of California, including the power to contract, rent, buy or sell personal or real property provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the primary purposes of this corporation.
- D. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

#### ARTICLE III

This corporation is organized pursuant to the General Non-profit Corporation Law of the State of California. This corporation does not contemplate pecuniary gain or profit to the members thereof and it is organized for non-profit purposes.

#### ARTICLE IV

The principal office for the transaction of the business of this corporation is located in the County of San Benito, State of California.

#### ARTICLE V

The general management of the affairs of this corporation shall be under the control, supervision and direction of the board of directors. The names and addresses of persons who are to act in the capacity of directors until the selection of their successors are (for a temporary six month period):

#### ARTICLE VI

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, participation and other rights and privileges of members, and their liability to dues and/or assessments and the method of collection thereof, shall be as set forth in the Bylaws.

#### ARTICLE VII

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any private individual. Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for evangelistic religious purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code. If this corporation holds any assets in trust, or a corporation is formed for charitable purposes, such assets shall be disposed of in such manner as may be directed by decree of the Superior Court of the County in which the corporation has its principal office, upon petition therefore by the Attorney General or by a person concerned in the liquidation, or in a proceeding to which the Attorney General is a party.

#### ARTICLE VIII

These articles of incorporation may be amended from time to time by the Board of Directors in conjunction with the approval of the membership of THE BIBLICAL CHURCH OF GOD, through its local congregations and their local governing boards.
