That the name of said corporation is The Taylor Mercantile Company, Limited.

That the purpose for which it is formed is to carry on the business of buying and selling merchandise, and doing all business necessarily thereto pertaining, buying and selling serials and farm products and live stock, and buying and selling and holding real - estate.

That the place where its business is to be transacted shall be the town of Taylor, Bingham County, Idaho.

That the term for which it is to exist is fifty years from and after the date of its incorporation.
