AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP
OF
WILDERNESS RANCH, LTD.

Pursuant to the provisions of Section 53-209 of the Idaho Code, the undersigned do hereby executed, in duplicate, this Certificate of Amendment for the purpose of amending the Certificate of Limited Partnership of Wilderness Ranch, Ltd. The following information is set forth, as required by said §53-209:

1. The name of the limited partnership is WILDERNESS RANCH, LTD.
2. A "Restated Certificate of Limited Partnership of Wilderness Ranch, Ltd." (hereinafter "Certificate of Limited Partnership") was filed in the office of the Idaho Secretary of State on July 23, 1982.

3. The Certificate of Limited Partnership is hereby amended in the following manner:

Paragraph 4 of the Certificate of Limited Partnership is hereby amended to read as follows:

- "4. The name and business address of each of the general partners of the partnership are as follows:

Paragraph 6 of the Certificate of Limited Partnership is hereby amended to read as follows:

"6. Each of the limited partners has contributed the sum of \$10.00 to the partnership. Terraco has contributed cash of \$68,171.00, and S & L Development Company has contributed cash of \$75,000.00. Terraco has contributed property having an agreed value of \$46,500.00."

Paragraph 7 of the Certificate of Limited Partnership is hereby amended to read as follows:

"7. If and when additional capital is needed, the general partners may be required to make additional contributions of capital, as provided in the Articles of Limited Partnership of Wilderness Ranch, Ltd. The limited partners are not obligated to make any additional contributions to the partnership."

Paragraph 8 of the Certificate of Limited Partnership is hereby amended to read as follows:

"8. The contributions of the limited partners are to be returned to each limited partner upon dissolution of the partnership, after payment of all debts and liabilities of the partnership and the expenses of liquidation."

Paragraph 9 of the Certificate of Limited Partnership is hereby amended to read as follows:

"9. The limited partners shall not be entitled to any distributions, other than the return of their initial capital contributions."

The following new paragraph is hereby added to the Certificate of Limited Partnership:

"15. The name and address of the registered agent for service of process required to be maintained by Idaho Code §53-204 is:
