KNOW ALL MEN BY THESE PRESENTS: That we, the under-
signed natural persons of lawful age and citizens of the
United States, for the purpose of forming a corporation
pursuant to the provisions of the Idaho Business Corpor-
ation Act (Title 30, Idaho Code) do hereby certify as
follows:

FIRST

The name of the corporation is

Scenic Bay Marine Repair, Incorporated

SECOND

The corporation is to have perpetual existence.

THIRD

The purposes and objects for which the corporation is
organized include the transaction of any or all lawful
business for which corporations may be incorporated under
the Idaho Business Corporation Act (Title 30, Idaho Code).

FOURTH

The aggregate number of shares which the corporation
shall have authority to issue is: 100,000
Such shares are to consist of one class only. The par
value of each of such shares shall be \$1.00,
which stocks shall not be issued until fully paid for,

Any stock or obligations issued by the corporation shall first be offered to the stock holders of the corporation.
