ARTICLES OF INCORPORATION OF BINGHAN COUNTY CHRISTMAS TREE FANTASY, INC.

The undersigned, a citizen of the United States desiring to form a nonprofit corporation under the Idaho Nonprofit Corporation Act does hereby certify:

ARTICLE I

The name of the corporation shall be Bingham County Christmas Tree Fantasy, Inc.

ARTICLE II

The existence of this corporation shall be perpetual unless sooner terminated by operation of law or by voluntary termination.

ARTICLE III

The purpose for which this corporation is organized is exclusively for charitable, educational and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or a corresponding section of any future Federal Tax Code.

ARTICLE IV

No part of the net earnings of the corporation shall innure to the benefit of or be distributable to its members, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding Section of any future federal tax code or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or corresponding Section of any future federal tax code.

ARTICLE V

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI

The corporation shall have no directors but shall be governed by a Board of Members, all of one class, the number of which shall be eighteen, the Board of Members shall at their annual meeting each year elect the members for a term of one year or until their successors are elected and qualified. The By-Laws shall set forth the manner of election or appointment, and the qualifications and rights of the members of the class. The initial Board of Members of said corporation are as follows:
