Restating Articles of Incorporation

We contacted you in March, 1997, requesting information for amending our articles of incorporation, and received a copy of the Idaho Nonprofit Corporation Act (1995). We have rewritten our constitution, which governs our internal affairs, and have restated our Articles of Incorporation, following the guidelines presented in the Idaho Act.

Enclosed are an original and a copy or our restated Articles of Incorporation, an original and copy of our newly ratified constitution, and a check for \$30 to cover the fee for restating our Articles of Incorporation. Even though some of the articles changed little, we chosed to completely restate and simplify the articles rather than amend the current ones. We dropped many of the earlier articles that were concerned with the operation of internal affairs. Details of operating our internal affairs are now covered in our new constitution.

You will note the the current directors (who are also our church elders) have unanimously approved the adoption of the restatement, and have all signed the restated Articles of Incorporation. As detailed in our previous Articles of Incorporation, our church has no "members", and thus the Restatement requires no vote for approval by the members, simply adoption by the directors. Also, approval of the restatement is not required by any person other than our current directors.
