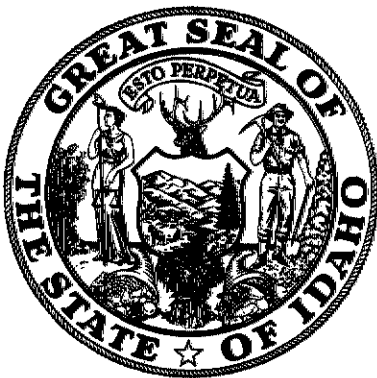

The undersigned, being Idaho corporations, and acting as incorporators of this corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Centurion Associates, Inc.

SECOND: The period of duration is: Perpetual.

THIRD: The purpose or purposes for which the corporation is organized is: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to the ownership, maintenance and operation of an airplane.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is: 10,000 shares at \$10.00 par value.




