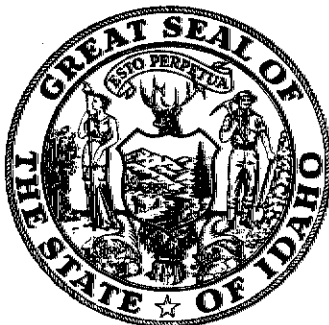

ARTICLES OF AMENDMENT

Name of corporation: Cougar Mountain Software, Inc.  
No. 72200

Amendment adopted: That there shall be 1,000 shares of stock  
valued at \$1.00, or \$1,000.  
This shall replace the \$25,000 as in the original articles  
of incorporation dated March 2, 1983.

Date of adoption: August 1, 1996

Number of shares outstanding: 1,000 shares.  
All 1,000 shares are entitled to vote.

Number of shares voted for this amendment:  
All 1,000 shares voted for this amendment

Exchanges, reclassification or cancellation of shares:  
There are no changes of stock required.  
There are no reclassification required.  
There is no cancellation of shares required.


Change in the amount of stated capital:  
There is a change in the amount of the capital but this  
amendment is to correct the earlier amount stated. Since  
our CPA has kept our books (which was about 1984) we have  
used \$1,000 as the amount of stated stock, and we have  
used 1,000 shares in all of our records. So all of our  
records have shown these amounts for approximately 12 years.  
While looking through some of the earlier records we happened  
to notice that it was originally stated as \$25,000. This is  
to correct that stated figure.
