ARTICLES OF INCORPORATION

OF

LAND SERVICES, INC. 30 SEP 25 FM 1 40

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned being a natural person over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "Idaho Business Corporation Act", and to that end do hereby set forth:

- The name of the corporation is: LAND SERVICES, INC.
- 2. The period of duration of this corporation shall be perpetual.
- 3. The purposes for which this corporation is organized:
- (a) Primarily to engage in the business of contracting for the buying or selling or negotiations for lands, rights-of-way, ingress and egress, for any purpose and for the acquisition or condemnation of the same.
- (b) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- 4. The county in the State of Idaho where the principal office for the transaction of business of the corporation is located is in the County of Twin Falls and the name of the registered agent is Robert C. Weaver and the

address of the registered office shall be 130 North Broadway, Buhl, Idaho 83316.

- 5. The aggregate number of shares which the corporation shall have authority to issue is 100, having no par value. All of said stock shall be known as common stock and shall be nonassessable.
- 6. The names and post offices address of the incorporator is as follows:

- 7. The directors of the corporation shall have the power to sell any authorized but unissued stock at any time and to any person, and no stockholder shall be entitled, as of right to subscribe for or purchase of any of such additional shares of stock.
- 8. The number of directors of the corporation may be fixed by the By-Laws, but shall not be less than the number required by law.

The number of directors constituting the initial Board of Directors shall be three (3), and they shall serve as directors until their successors are elected and qualified.
