KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:

First. That the name of said corporation is the SAINT JOE LUMBER COMPANY, Limited.

Second. That the purposes for which it is formed are Manufacturing and dealing in Lumber and all its products; Dealing in Timber and Timber Lands; Merchandising in all its branches.

Third. That the place where its principal business is to be transacted shall be the town of Harrison, Kootenai County, State of Idaho.

Fourth. That the term for which it is to exist shall be twenty-five years from and after the date of its incorporation.

Fifth. That the number of its directors shall be five, and the names and places of residence of those appointed for the first year are:
