ARTICLES OF INCORPORATION

OF

FURNITURE WEST, INC.

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is FURNITURE WEST, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are: To carry on and conduct the business of a retail furniture outlet, as well as including the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is FIFTY THOUSAND DOLLARS (\$50,000.00), which shall be divided into Fifty Thousand (50,000) shares of common stock, the par value of each share shall be One Dollar (\$1.00), and such stock shall be nonassessable.

V.

The address of the initial registered office of the corporation is 1114 Pullman Road, Moscow, Idaho 83843, and the name of its initial registered agent at such address is James B. DeMeerleer.

3 elected and shall qualify are:





