# Articles of Incorporation of the Heela Mining Company.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation, and hereby do become a corporation, under the laws of the State of Washington, and we hereby adopt the following Articles of Incorporation.

## Artiele I.

The name of this corporation shall be the Heela Mining Company.
