- First. And we hereby certify: That the name of said Corporation is, The Pacific Legion of Honor.
- Second. That the purposes for which it is formed, are the affording of substantial benefits to, and the promoting of fraternal relations among the members during life, and the furnishing of financial aid and indemnity to the beneficiaries of beneficial members (after death of such beneficial members) in accordance with the Articles of Association, by laws, rules, and regulations of the association and of acquiring such real and personal property as may be deemed necessary to enable it to accomplish its fraternal and benevolent purpose and the power of mortgaging, selling, transfering and disposing of the same.
- Third. That the place where its principal business is to be transacted shall be the City of Boise, County of Ada, in the State of Idaho.

- Fourth. That the term for which it is to exist is Fifty Years from and after the date of its incorporation.


