ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is: POCATELLO CHILDREN AND ADOLESCENT CLINIC, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: medical treatment of children and adolescents and the transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is FIVE THOUSAND (5000) shares common voting stock at \$50.00 per share, par value.

FIFTH: The address of the initial registered office of the corporation is: 527 South 12th Avenue, Pocatello, Idaho and the name of its initial registered agent at such address is: Kerry Casperson.
