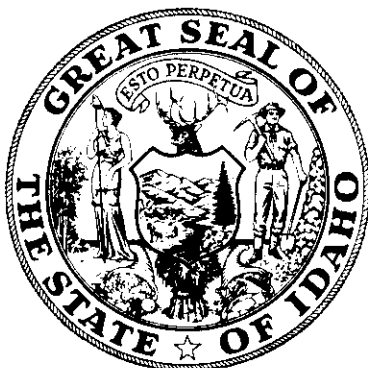

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is THE LEASING COMPANY, INC.

SECOND: The period of duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the leasing of commercial rental properties and all other business not forbidden by law.

FOURTH: The aggregate number or shares which the corporation shall have authority to issue is 5,000 with a par value of \$1.00.

FIFTH: The address of the initial registered office of the corporation is The Empire Building, 205 N. 10th Street, Suite 617, Boise, Idaho, 83702, and the name of its initial registered agent is Thomas A. Troy.
