The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

#### ARTICLE I

The name of the corporation is Finish Carpentry Ry Phil, Inc., (hereafter "Corporation").

### ARTICLE II

The purposes for which this Corporation is organized are as follows:
