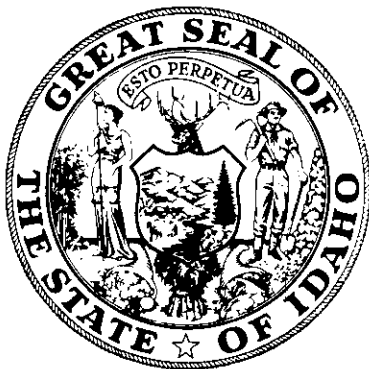

ARTICLES OF AMENDMENT OF  
E-DAH-HOE PUBLISHING CO., INC.

ARTICLE I

NAME

The name of this corporation is E-DAH-HOE  
PUBLISHING CO., INC.

ARTICLE II

AMENDMENTS

Article IV of the Articles of Incorporation of  
said corporation shall be amended by deleting the last  
sentence thereof and substituting therefor the following:

"Each of such shares shall have a par value of  
\$100."

ARTICLE III

DATE OF ADOPTION

The Amendment has been approved by the Board of  
Directors prior to the issuance of any shares of stock of  
said corporation at a meeting held on the 1st day of April,  
1985, at which meeting there was at all times an acting  
quorum of the Board of Directors.

ARTICLE IV

NUMBER OF SHARES OUTSTANDING

At the time of the adoption of the Amendment there  
were no outstanding shares of the stock of the corporation  
and hence there were no shares entitled to vote on the  
Amendment.

ARTICLE V

EFFECT ON ISSUED SHARES AND STATED CAPITAL

The Amendment does not provide for an exchange,  
reclassification or cancellation of issued shares. The  
Amendment does effect a change in the amount of stated  
capital by changing the stock of the corporation from no par  
value to \$100 par value which will change the stated capital  
from no dollar amount to a \$500,000 dollar amount.


