

# Articles of Incorporation of the Idaho Cable Traction Tramway Company.

Know all men by these Presents, that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Territory of Idaho: And we hereby certify: First: That the name of said corporation is "Idaho Cable Traction Tramway Company; Second: That the purposes for which it is formed are to manufacture sell introduce into operation and operate the Endless cable system of operating railways within the Territory of Idaho, with all the inventions devices and machinery belonging or appertaining thereto and to purchase acquire bargain sell transfer and assign letters patents securing, covering or relating to such endless cable railway system or any machinery inventions or devices employed therein relating thereto and to bargain sell, transfer and assign rights and licenses to construct and operate such endless cable railways and to manufacture and use such inventions devices and machinery

And also to undertake and carry on all business necessary or proper to the carrying out of these objects

Third: That the place where its principal business is to be transacted shall be Hailey Alturas County Idaho Territory

Fourth: That the term for which it is to exist is Fifty years from and after the date of its Incorporation

Fifth: That the number of its Directors or Trustees shall be Five and that the names and residences of those who are appointed for the first three months are:
