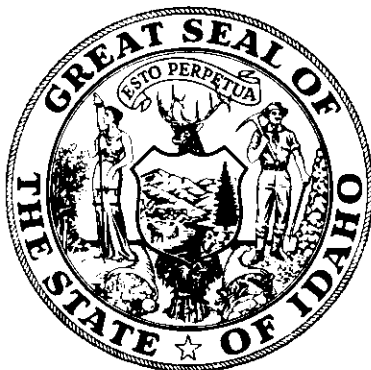

SECOND ARTICLES OF AMENDMENT

OF

CHURCH OF NEW HOPE ADVENT CHRISTIAN CHURCH, INC.

COME NOW THE PRESIDENT AND SECRETARY, RESPECTIVELY,
of the Church of New Hope Advent Christian, Inc., an Idaho
nonprofit corporation, who state that, pursuant to a duly
noticed special meeting of the Church of New Hope on August 3,
1986, where a quorum of the members of said non-profit
corporation were present and where a vote was taken at said
meeting to amend the original Articles of Incorporation in
order to change Articles IV, VI, and VIII, and where a majority
of the quorum voting by their vote approved that said Articles
of Incorporation be amended accordingly and that said vote was
taken pursuant to a duly adopted resolution of the Board of
Directors (Ministry Council) and pursuant to sufficient and
legal notice of said resolution prior to said vote,

NOW THEREFORE, THE ARTICLES OF INCORPORATION OF
CHURCH OF NEW HOPE (ADVENT CHRISTIAN), INC., originally filed
with the Idaho Secretary of State's Office on 10 March 1980 as
Instrument No. 63380 which were first amended by Articles of
Amendment filed with the Secretary of State's Office on 21 July
1986 are hereby further amended as follows:


FIRST: That Article IV of said original Articles of
Incorporation be changed to read as follows: The purpose of
this corporation shall be to honor God through the announcement


of the good news of hope through Jesus Christ and through ministries that will enable people in increasing measure to reflect the character of Christ.

SECOND: That Article VI of said original Articles of Incorporation be changed to read as follows: The Constitution and By-Laws shall govern this corporation in compliance with the Idaho Nonprofit Corporation Act.

THIRD: That Article VIII of said original Articles of Incorporation be changed to read as follows: The Ministry Council shall constitute the Board of Directors of this corporation and the members elected to the Ministry Council shall constitute its directors and the manner of election of the directors and the number of directors shall be established by the By-Laws of this corporation but in no event shall such number of directors be less than three.


