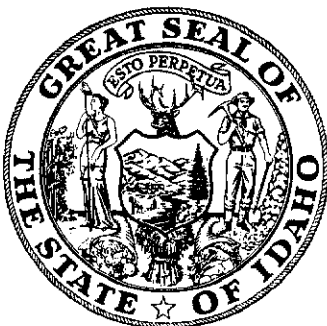

ARTICLES OF INCORPORATION
OF
VALLEY SHEET METAL, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: That the name of the corporation is:

VALLEY SHEET METAL, INC.

SECOND: That the period of its duration is perpetual.

THIRD: That the purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: That the aggregate number of shares which the corporation shall have authority to issue is fifty (50), all of one class, no par value.

FIFTH: That the mailing address of the corporation is 3200 South Yellowstone Highway, Idaho Falls, ID 83402; that the name of the corporation's initial registered agent is: Robert A. Scarr, 484 W. 18th, Idaho Falls, ID 83402.

SIXTH: That the Shareholders of the corporation may from time to time, distribute to themselves out of capital surplus of

the corporation a portion of its assets, in cash or property, subject to the following provisions:

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent.

(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares.

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the Stockholders receiving the same concurrently with the distribution thereof.

SEVENTH: That the number of Directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the Stockholders or until their successor is elected and shall qualify are:


