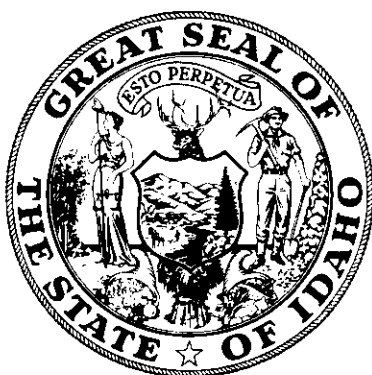

We, the undersigned, Don Dellos, Brian Lee, and Carl Gilbert, acting incorporators of a corporation under the Idaho Statutes do hereby adopt the following Certificate of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is the FIRST CHRISTIAN AND MISSIONARY ALLIANCE CHURCH, INC.

ARTICLE II.

The corporation is a not-for-profit corporation organized and operated exclusively for religious purposes, is not formed for pecuniary profit or financial gain, and no part of the assets, income or profits of the corporation is distributable to or insures to the benefit of its members, trustees, or officers or any private person. The term of existence of this corporation is perpetual.

ARTICLE III.

The purpose for which the corporation is organized is to promote the cause of the Christian religion; to promulgate the doctrines and teachings of the Christian and Missionary Alliance, a corporation organized under the laws of the State of New York, with which this corporation is affiliated and connected as a subordinate body, and should this corporation cease to exist as a corporate body in affiliation, cooperation or connection with the said parent corporation, viz., The Christian and Missionary Alliance, which has its principal office at 350 North Highland Avenue, Nyack, New York 10960-0992, Rockland County, State of New York, and subject to its purposes, usages, doctrines and teaching, then all of the real and personal property, appurtenances and effects then owned or held by this corporation shall revert to and become the property of the incorporated or supervising body of The Christian and Missionary Alliance within whose jurisdiction said corporation is located or with which it is affiliated; to provide for its members a place of worship to be conducted in accordance with the rules and laws of the aforementioned parent corporation, The Christian and Missionary Alliance of New York; to receive, hold and disburse gifts, bequests, devises and other funds for its purposes, and to own and maintain suitable real estate and buildings

for its purposes and do all things necessary and incident thereto.

ARTICLE IV.

The street address of the initial registered office and the name of the initial registered agent at such address is as follows: Don Dellos, 515 Northland, Pocatello, Idaho 83201.

ARTICLE V.

Prior to the delivery of the Certificate of Incorporation for filing, all approvals or consents required by law will be endorsed upon or annexed hereto.

ARTICLE VI.

This corporation shall conduct its business in accordance with the Constitution for Churches as set forth in the Manual of The Christian and Missionary Alliance as it may be amended by General Council from time to time.

ARTICLE VII.

The number of trustees for the first year of the existence of the corporation shall be three (3) and the name and street address of each trustee are:

scribed in the bylaws of the association.


At the aforesaid meeting, twenty-seven (27) members, representing
