KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho;

AND WE HEREBY CERTIFY:-

I.

That the name of said corporation is and shall be "Fremont Mercantile Company, Limited".

II.

That the purposes for which it is formed are: To buy, sell, deal in and with merchandise, hardware, and furniture of all kinds, and to conduct and carry on a general retail and wholesale mercantile business;

To buy, sell and deal in grains, seeds, hay, and all kinds of farm produce, green and staple groceries, lime, ice, lumber, paints, oils and glass;

To purchase, take and lease, sell and dispose of, or otherwise acquire real and personal property which the corporation may deem necessary or convenient for the purposes of its business;

To do any and all things in these articles of incorporation set forth, and to the same extent and as fully as a natural person might or could do, and not inconsistent with the laws of the State of Idaho.

III.

That the place where its principal business is to be transacted shall be Teton, Fremont County, State of Idaho.

IV.

That the term for which it is to exist shall be Fifty (50) years from and after the date of its incorporation.

V.

That the number of its directors shall be Three (3), and the

names and residences of those who are appointed for the first year are as follows:-

That the amount of the capital stock of this corporation shall be Twenty-five Thousand (\$25,000.00) Dollars, divided into Two Thousand Five Hundred shares, of the par value of Ten (\$10.00) Dollars per share, each.
