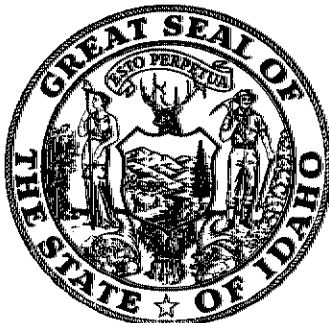

The undersigned, acting as incorporator under the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE I.

NAME OF THE CORPORATION

The name of the corporation is AMATEUR RADIO WORLD, INC. ("Corporation").

ARTICLE II.

DURATION

The Corporation shall have perpetual existence.

ARTICLE III.

PURPOSES OF THE CORPORATION

1. To engage in the purchase and resale, repair, manufacture, import, export, distribution, promotion, and all other activities for dealing in the goods and services associated in any way with radio equipment and its operation, including but not limited to the purchase or lease and improvement of property suitable to aid in dealing in the goods and services associated with radio equipment and its operation
2. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a business corporation may be organized under the laws of the State of Idaho.
3. To do any acts and perform any business permitted by the Idaho Business Corporation Act.
