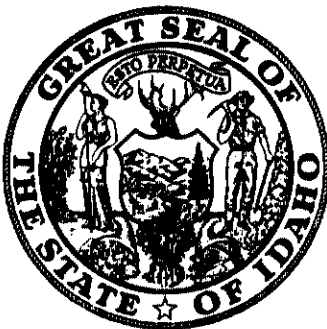
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is EAGLE CREST WATER USERS ASSOCIATION, INC.

SECOND: The period of this corporation's duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to conduct the business of maintaining a water system servicing its members/shareholders real property and collecting and disbursing funds of the members/shareholders. This corporation shall be non-profit.

FOURTH: Provisions denying preemptive rights are: Pursuant to the By-Laws.

FIFTH: The aggregate number of shares/membership certificates which the corporation shall have authority to issue is nine shares/membership certificates with no par value.

SIXTH: Provisions for the regulation of the internal affairs of the corporation: Pursuant to the By-Laws.

SEVENTH: The address of the initial registered office of the corporation is P.O. Box 1605 Coeur d'Alene, ID,  
(2120 BOYD AVENUE, COUER D'ALENE, IDAHO 83814)

and the name of the registered agent at such address is

Dennis Walton.

EIGHTH: The number of directors for the corporation shall be not less than two (2), nor more than five (5). The number of directors constituting the initial board of directors of the corporation is three (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

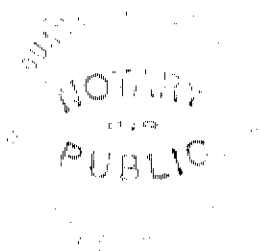
