**ARTICLE OF INCORPORATION
OF
WEIPPE WESLEYAN YOUTH CENTER, INC.**

I

NAME:

The name of the corporation is the Weippe Wesleyan Youth Center, Inc.

II

PERIOD OF DURATION:

The corporation shall have perpetual existence.

III

PURPOSE AND NON-PROFIT STATUS:

This corporation shall be a non-profit corporation. The corporation is organized to promote the well-being of the youth of the area by providing a safe place for education and recreation; and for such other charitable and educational purposes as may be permitted by law and consistent with Title 26 Section 50 1 (c)(3) U.S. Code. Should this corporation dissolve, all of the assets of the corporation shall be transferred to the Weippe Wesleyan Church or to the Northwest District of the Wesleyan Church.

IV

CLASSES AND NUMBER OF DIRECTORS:

There shall be at least six adult directors, three of whom shall be trustees of the Weippe Wesleyan Church, and three or more who shall oversee the day-to-day operations of the Weippe

Wesleyan Youth Center. The trustees are elected to three-year terms by the members of the Weippe Wesleyan Church. The other directors shall serve either by virtue of the offices they hold or by appointment to the board. They shall remain as directors as long as they hold those offices or until their appointment is rescinded. There shall also be a youth advisory board of directors consisting of at least four young people, selected by the other directors, to represent the local junior high and high schools. QUALIFICATIONS OF DIRECTORS:

At least one director shall be the pastor or assistant pastor of the Weippe Wesleyan Church. One director shall be the administrator/coordinator of the Weippe Wesleyan Youth Center. Other directors shall be appointed by the trustees. All board positions are subject to approval by the local board of administration of the Weippe Wesleyan Church.

V

MEMBERSHIP AND VOTING RIGHTS:

This corporation shall not have a membership. The members of the Weippe Wesleyan Church elect members to the local board of administration of the Weippe Wesleyan Church, which in turn oversees the board of the Weippe Wesleyan Youth Center.

VI

PRINCIPLE BUSINESS OFFICE:

The principle business office of the corporation shall be located in Weippe, Clearwater County, Idaho.

VII






