Articles of Incorporation for Eagle Idaho Swim Team An Idaho Non-profit Corporation

To the Secretary of State of the State of Idaho
The undersigned, in order to form a Corporation under the provisions of Title
Chapter 3, Idaho Code, submits the following articles of incorporation:

Article 1:

The name of the corporation shall be **Eagle Idaho Swim Team, INC.**

Article 2:

This corporation is organized exclusively for charitable and educational purposes and for the purpose of fostering national or international amateur sports competition (but only if no part of its activities involve the provision of athletic facilities or equipment) within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation and the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law.

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. It is organized under the Non-profit Public Benefit Corporation Law for charitable purposes.

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation and this corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of or in opposition to any candidate for public office.

All corporate property is irrevocably dedicated to the purposes stated above. No part of the net earnings of this corporation shall inure to the benefit of any of its directors, trustees, officers, private shareholders or members, or to individuals, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article.

The corporation shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1954 or corresponding provisions of any later federal tax laws.

The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1954 or corresponding provisions of any later federal tax laws.

The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1954 or corresponding provisions of any later federal tax laws.

The corporation shall not make any investments in such a manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1954 or corresponding provisions of any later federal tax laws.

The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954 or corresponding provisions of any later federal tax laws.

Article 3:

The street address of the registered office is 1125 E. State Street, Eagle, ID 83616, and the registered agent at such address is Loni Ellis. Eagle is located in Ada County.

Article 4:

The Board of Directors shall consist of the following people:

Article 5:

The name and address of the incorporator is Edward Kosydar, 2373 N. Ram Avenue, Eagle, Idaho 83616.

Article 6:

The mailing address of the corporation shall be 1125 E. State Street, Eagle, ID 83616.

Article 7:

The corporation does have voting members.

Article 8:

On the dissolution and winding up of this corporation, after paying or adequately providing for the debts, obligations and liabilities of the corporation, the remaining assets of this corporation shall be distributed to such organization (or organizations) organized and operated exclusively for the purposes of this corporation as set forth in Article 2 of these Articles of Incorporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States internal revenue law) and which has established its non-profit status under the provisions of Title 30, Chapter 3, of the Idaho State Code.
