ARTICLE IV

PURPOSE

The general purpose for which this corporation is formed is to conduct and carry on the business of buying, selling, and dealing in all kinds of livestock, grain, hay, or other farm produce, farm products, and provisions, purchasing or acquiring, and selling and otherwise disposing of stocks, supplies, equipment, accessories, products and by-products of such business, and all other kinds of goods, wares, and merchandise.

In addition to the above mentioned purpose, the corporation shall have the power to engage in any other lawful activity or activities in Idaho and throughout the world.

ARTICLE V

CAPITALIZATION

The total authorized capital stock of this corporation is Twenty Five Thousand Dollars (\$25,000.00), divided into Twenty Five Thousand (25,000) shares of common stock of a single class, each having a par value of One Dollar (\$1.00). All of the voting power of the capital stock of this corporation shall reside in the common stock.
