#### ARTICLES OF INCORPORATION

KNOW ALL PERSONS BY THESE PRESENT: That we, the undersigned, each being a natural person and a citizen of the United States of America, hereby associate ourselves together for the purpose of forming a non-profit corporation and for purposes hereinafter stated under the provisions of Chapter 3, Title 30, Idaho Code, and acts amendatory and supplemental thereto, do hereby adopt the following Articles of Incorporation:

#### Article I

The name of the corporation shall be MOUNTAIN HOME CHAMBER OF COMMERCE, INC.

#### Article II

The period of duration of the corporation is perpetual.

#### Article III

MOUNTAIN HOME CHAMBER OF COMMERCE, INC. is organized as a non-profit organization with the purpose or purposes to promote industrial, commercial and recreational development within and in the vicinity of the City of Mountain Home, County of Elmore, State of Idaho; to promote and assist the growth and development of business concerns and others in the area; to acquire, own, use, manage, lease, convey or otherwise dispose of and deal in real property or in any interest therein, within, and in the vicinity or the City of Mountain Home, County of Elmore, State of Idaho; to buy; sell and otherwise deal in all forms or personal property in order to promote said industrial, commercial, business and recreational development to increase employment in the area and improve the welfare of the people; any lawful activity related to such business, and the transaction of any or all other lawful purpose for which a corporation may be incorporated under the Idaho Business Corporation Act.

The corporation will not carry on any activity not permitted by corporations exempt under Section 501(c)(6), or corresponding sections of I.R.C., or make contributions deductible under Section 170(c)(2) of I.R.C.

This corporation hereby reserves the right to alter, amend, change or repel any provisions of these Articles of Incorporation in the manner now provided, or which may hereafter by provided, by the laws of the State of Idaho, and all rights, privileges and powers by these Articles of Incorporation conferred are subject to this provision.

#### Article XI

This corporation, as a non-profit corporation, shall comply fully with the provision of Section 501(c) of the Internal Revenue Code of the United States of America, and subsequent Treasury regulations thereto. No part of the monies or assets of this corporation shall inure to the profit of any individual or non-qualifying agency, either during the existence of this corporation or upon its dissolution, except that reasonable compensation may be paid for goods furnished and the performance of services to or for the benefit of the corporation. In the event of dissolution of this corporation, its assets shall be distributed only to such entities as would qualify under Section 501(c) of the Internal Revenue Code of the United States and/or any other applicable laws of the State of Idaho or of the United States.
