ARTICLES OF INCORPORATION

- 1. Name. The name of the corporation is BPA Health, Inc. (the "Corporation").
- The aggregate number of shares the Authorized Shares. Corporation is authorized to issue shall be fifty thousand (50,000), all of which shall be common voting stock with \$1.00 par value. When issued, shares shall be fully paid and not subject to assessment.
- Registered Office and Agent. The registered office of the Corporation is 1501 Tyrell Lane, Boise, Idaho 83706 and its registered agent at that address is D. Whitman Jones.
- Purpose. The Corporation is organized to transact the business of disability insurance as a limited managed care plan, and such business activity reasonably and necessarily incidental to such insurance business.
- Board of Directors. The Corporation's board of directors shall 5. consist of no fewer than five (5) and no more than fifteen (15) directors, which number shall be fixed as provided in the Corporation's bylaws.

- 7. <u>Voting</u>. Each outstanding share entitled to vote shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of shareholders. Shareholders do not have the right to cumulate their votes.
- 8. <u>Indemnification</u>. The Corporation shall indemnify the directors and officers of the Corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter by amended (but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader indemnification rights than the existing Idaho Business Corporation Act permits prior to such amendment).
- 9. <u>Limitation of Liability</u>. No director shall be liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by a director to which he or she is not entitled; (ii) an intentional infliction of harm on the Corporation or its shareholders; (iii) an intentional violation of criminal law; or (iv) an unlawful distribution.


