United States of America, do hereby associate ourselves for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and we do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I

The name of this corporation shall be "ASCORP, INC."

We, the undersigned, being all adult citizens of the

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue is Two Hundred Fifty Thousand (250,000); the shares shall consist of one (1) class only; the par value of each share shall be the sum of One Dollar (\$1.00); the total authorized capital stock of the corporation is the sum of Two Hundred Fifty Thousand Dollars (\$250,000.00). The stock of this corporation shall be nonassessible.
