

ARTICLES OF INCORPORATION

OF

DESERT-MOUNTAIN, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is DESERT-MOUNTAIN, INC..

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are:

- (a) To engage in the general retail and wholesale business; to construct, own, operate, buy, sell, lease, equip and maintain buildings, structures, warehouses, stores and machinery necessary for the conduct of the business of said corporation; to buy, sell, trade, manufacture, deal in, and deal with goods, wares, machinery and merchandise of every kind and nature, and to carry on such business as wholesalers, retailers, importers, and exporters; to require all such merchandise, supplies, materials, and other articles as shall be necessary or incidental to such business; to hold, acquire, mortgage, lease, and convey real and personal property to any part of the world, so far as necessary or expedient in conducting the business of the corporation, and to have any and all powers above set forth as fully as natural persons, whether as principals, agents, trustees, or otherwise.

- (b) To buy, sell, own, lease, rent, mortgage, trade, hypothecate, or otherwise deal in all and every sort of property, whatsoever real, personal or mixed and to borrow money and in return therefore, to issue its notes or other evidences of indebtedness;
- (c) To do each and everything necessary or proper for the accomplishment of any of the purposes or attainment of the one or more of the objects herein enumerated and to conduct any and all other business not forbidden by law.

ARTICLE IV

The authorized capital stock of the corporation shall consist of fifty (50) shares of no par value common stock. All of the stock shall be of the same class, have the same powers and voting rights and shall not be assessable for any purpose whatsoever.

ARTICLE V

Provisions denying preemptive rights are: there shall be no preemptive rights to any issued or outstanding corporate shares.

ARTICLE VI

Provisions for the regulation of the Internal affairs of the corporation shall be set out in the by-laws of the corporation.

ARTICLE VII

The address of the initial registered office of the corporation is Route 5 Box 8748 Grandview Drive, Twin Falls, Idaho, 83301, and the name of the initial registered agent at

such address is Norm Lancaster.

ARTICLE VIII

The number of directors constituting the initial Board of Directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and shall qualify is:






