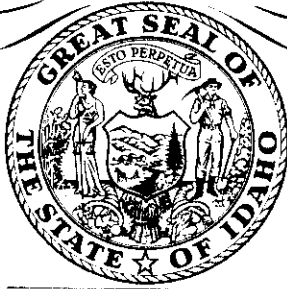

### CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

ARTICLE OF AMENDMENT TO

ARTICLES OF INCORPORATION

Upon notice being given as required by law, a meeting of the members of said corporation was held Feb. 20, 1963 at which meeting the Articles of Incorporation were amended by a majority of a quorum attending said meeting.

The Articles of Incorporation were amended by adding Article VIII which reads as follows:

Article VIII

In the event of dissolution of this corporation, any remaining assets shall and will be transferred to some lawfully incorporated religious organization which meets the provision of Section 501 (c) of the Internal Revenue Code, that organization to be named at time of dissolution by a majority of a quorum of members of said corporation present and voting at a duly called meeting.
