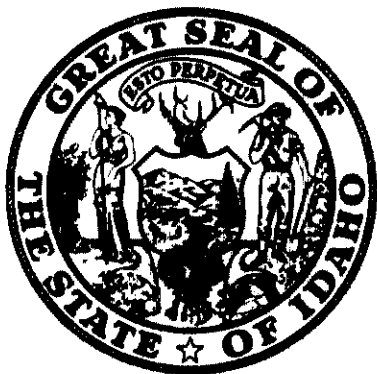

The undersigned, desiring to form a nonprofit, religious corporation under the Nonprofit Corporation Law of Idaho, does hereby certify:

1. Name. The name of the corporation is CHRISTIAN SCIENCE SOCIETY KETCHUM/SUN VALLEY, INC.
2. Status. The corporation is a nonprofit corporation.
3. Duration. The period of duration of this corporation is perpetual.
4. Purposes. The corporation is organized exclusively for religious purposes.
5. Powers. The corporation shall have all powers granted to corporations generally, specially including the power and authority to acquire, own, hold, mortgage, dispose of, and invest its funds in real and personal property for the use and benefit of the corporation.
6. Members. The corporation shall have one or more designated classes of members as set forth in the Bylaws. The manner of election or appointment, and the rights and qualifications of the members shall be set forth in the Bylaws. The members shall not be personally liable for the debts, liabilities, or obligations of the corporation.
7. Amendment. These Articles of Incorporation may be amended in the manner provided by the statutes of the State of Idaho at the time of amendment.
8. Directors. The number of directors constituting the initial executive board of the corporation is three (3). The names and addresses of the persons who are to serve as initial members of the executive board are:
