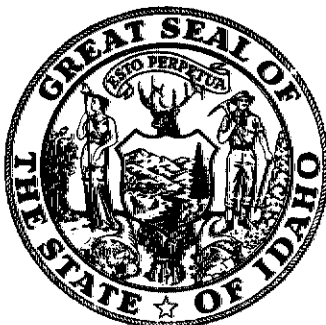

**CERTIFICATE OF INCORPORATION

FIRST, The name of the Corporation is Galen Blanc Auto Body, Inc.

SECOND, Its registered office in the State of Idaho is to be located at 1418 Nash, in the City of Boise, County of Ada. The registered agent in charge thereof is Galen L. Blanc at 1418 Nash, Boise, Idaho.

THIRD, The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, viz:

"The purpose of the corporation is to engage in any lawful act or activity for which the corporations may be organized under the general Corporation Law of Idaho."

FOURTH, CAPITALIZATION, The corporation shall have the authority to issue 50,000 Shares of Common Stock, each share to have a Par Value of \$1.00. The shares may be issued upon such terms as the Board of Directors may from time to time authorize.
