#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a non-profit corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation of such corporation.

## FIRST

The name of the non-profit corporation shall be: "Burley Bobcat Band Booster Club, Inc."

### SECOND

The period of it's duration is perpetual.

#### THIRD

The corporation is a non-profit corporation.

#### FOURTH

The purpose or purposes for which the non-profit corporation is organized is to provide for financial and material support for the Burley Bobcat Junior and Senior High School Band Program.

# FIFTH

The non-profit corporation shall have one class of members known as the Board of Directors. The manner of appointment of the members shall be to allow each parent of a Bobcat Band Member to vote at an annual meeting to elect said board members.

Each board member shall sit on the Board of Directors and each member shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the board members. The management of the corporation's affairs shall rest in the Board of Directors.
