

The name of this organization shall be "Wood River Muzzleloaders, Inc."

ARTICLE II

This corporation shall be a non-profit corporation.

ARTICLE III

This corporation shall exist until dissolved by a vote of the membership.

ARTICLE IV

The object of this organization shall be the encouragement of organized muzzleloading rifle, pistol, and shotgun shooting among citizens of the United States, residents in our community, with a view towards a better knowledge on the part of such citizens of the safe handling and proper care of muzzleloading guns, as well as improved marksmanship with this type of gun. It shall be a further purpose to forward the development of those characteristics of honesty, good fellowship, self-discipline, team play and self reliance which are the essentials of good sportsmanship and the true patriotism and to revive interest in the use and preservation of these ancient firearms.

ARTICLE V
