

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

CHALLIS MISSION CHURCH, INC.

was filed in the office of the Secretary of State on the **Fourth** day of **December,** A. D. One Thousand Nine Hundred **Fifty-nine,** and is duly recorded on Film No. **109** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Challis,** in the County of **Custer,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION CHALLIS MISSION CHURCH, INC.

We, the undersigned, natural persons, citizens of the United States, associate ourselves together as a corporation not for pecuniary profit under sections 30-1101, and 30-1102, Idaho Code, and certify as follows:

I

The name of this corporation shall be Challis Mission Church, Inc.

II

The purposes for which this corporation is organized are:

1. To establish and to maintain a church, and to do all things necessary or appropriate to establish and maintain a church.
2. To own and do all things necessary or appropriate to the ownership of both real and personal property, and to sell or mortgage the same.
3. To borrow money.

III

The duration of the corporation shall be perpetual.

IV

The location and post office address of the registered office of the corporation shall be Challis, Idaho.

V

The names of the incorporators, each of whom is a member, residing at Challis, Idaho, are: John W. Hutchison; Eleanor A. Hutchison; Audrey A. Baldwin; Marguerite Cobbley; Paul S. Fisher; Mabel Piva; and Mildred C. Fisher, all of full age.

VI

The promotion, operation and maintenance of said corporation shall be under the control of a board of elders of not less than five, nor more than 35, members.

VII

The management and business affairs of the corporation shall be conducted by a board of trustees or directors, each of whom shall be a member of the corporation.

VIII

That the following notice of the election of the trustess of said Challis Mission Church was published once a week for two weeks in the Challis Messenger, a weekly newspaper published at Challis, Idaho, where such election was held, and also by posting said notice for two weeks in a conspicuous place on the building where such election was held:

Notice is hereby given that a meeting of the members of the Challis Mission Church will be held at the church in Challis, Idaho, at 8 p.m. October 30, 1959, for the purpose of electing five trustees as the first step in incorporating said Challis Mission Church. Dated this October 15, 1959. John Hutchison, acting chairman.

That at such election Mecca Sanderlin served as secretary of meeting, at which a majority of the members of said church who were present voted, and which resulted in choosing the following as members of the first board of trustees: John W. Hutchison; Eleanor A. Hutchison; Audrey A. Baldwin; Marguerite Cobbley; Paul Fisher; Mabel Piva; and Mildred C. Fisher.
