

ARTICLES OF INCORPORATION

REDDINGER HEATING AND COOLING, INC. SECRETARY OF STATE

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Redinger Heating and Cooling, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to provide sales and service of heating and cooling, and RV parts and accessories and any other thing for which corporations may be incorporated under the Idaho business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is two hundred fifty thousand (250,000) shares, with a par value of One Dollar (\$1.00). 2,500 shares issued to Anna Marie Redinger and 2,500 shares issued to Donald F. Redinger as of January 5, 1994.


