# ARTICLES OF INCORPORATION OF POST FALLS TOURISM, INC.

#### ARTICLE I.

## NAME AND LOCATION OF CORPORATION

Section A. The name of this corporation shall be Post Falls Tourism, Inc.

#### ARTICLE II.

# NON-PROPIT CORPORATION

Section A. This Corporation is organized as a non-profit Corporation, and consequently will not have profits.

#### ARTICLE III.

#### PERIOD OF DURATION FOR THE CORPORATION

The period of existence for Post Falls Tourism, Inc. shall be perpetual.

#### ARTICLE IV.

#### PURPOSE OF THE CORPORATION

Section A. To receive monies from any source, to promote tourism within the City Limits, of the city of Post Falls, Idaho.

# ARTICLE V.

#### MEMBERS OF THE CORPORATION

The Corporation shall have one class of member, and a member must be qualified, by being an active member of the Post Falls Chamber of Commerce. Each member shall have one vote.

# ARTICLE VI.

#### CORPORATE MANAGEMENT

Section A. The management and the internal affairs of the Corporation, shall be managed by a Board of Directors, who need be residents of the State of Idaho, and members of this Corporation.

Section B. OFFICERS The officers of this Corporation shall consist of a President, a Vice-President, a Secretary, and

a Treasurer. The By-laws shall provide that officers be elected by the Board of Directors, as provided in the By-laws. Elections shall be held at such time and in such manner as is prescribed in the By-laws.

Such other officers and assistant officers and agents, as may be deemed necessary, may be elected by the Board of Directors, or chosen in such other manner as may be prescribed by the By-laws. Any two or more offices may be held by the same person, except the offices of President and Secretary.

#### ARTICLE X.

## MEETINGS OF MEMBERS

Section A. Meetings of members shall be held, within the City Limits of Post Palls, Idaho. And an annual meeting shall be held at such time as is provided in the By-laws, and Directors' shall be elected at such annual meeting as the By-laws provide.

Section B. Special meetings of the members may be called by the President, by the Board of Directors', or by members having at least 1/10th. of the vote entitled to be cast at such meeting.

#### ARTICLE XI.

#### CLASSIFICATION OF DIRECTORS

Section A. This Corporation shall have seven Directors', that will be divided into three classes. The term of the office of the Directors' of the first class is to expire at the first annual meeting of the members after their election, and this class shall consist of two Directors'; The second class of Directors' is to expire at the second annual meeting after their election, and there shall be two of these Directors'; The third class of Directors' shall expire at the third annual meeting after their election, and shall consist of three Directors'. No classification of Directors' shall be effective prior to the

first annual meeting of the members.

# ARTICLE XII.

# INDEMNIFICATION OF OFFICERS, DIRECTORS

The Corporation shall have the power to indemnify any person who was or is a party, or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether Civil, Criminal, Administrative, or Investigative, other then an action by or in the right of the Corporation, by reason of the fact that he or she is or was a Director, or Officer of the Corporation, or is or was serving at the request of the Corporation as a Director, or Officer, against expenses, including attorneys fees, judgments, fines and amounts paid in settlement, actually and reasonably incurred by him or her in connection with such action, suit or proceeding, if he or she acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the best interest of the Corporation, and with respect to any criminal action or proceeding, had no reasonable cause to believe his or her conduct was unlawful.
