

Dear Taxpayer:

Your application for an Idaho Seller's Permit Number has been accepted. You have been approved to file on a monthly basis, and the number assigned to you is shown on the attached permit. Tax reporting forms (returns) are being sent to you in a separate mailing. You must file a return even if no tax is due.

If you have been approved to file on a monthly basis, and want to change your filing frequency, after one year you may request, in writing, to change to a less frequent filing cycle provided:

1. Your collections amount to less than \$500 per quarter, and
2. You have no record of delinquent filings.
