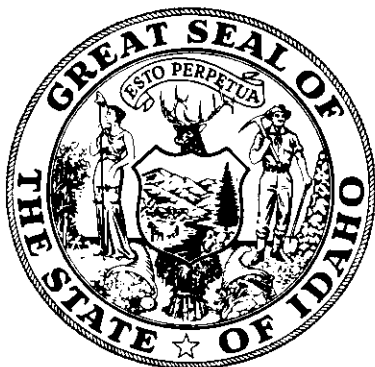

ARTICLES OF INCORPORATION

of

BUCKS MACHINE SHOP, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Bucks Machine Shop, INC.

SEONCD: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporations Act.

FOURTH: The corporation shall have authority to issue 5,000 shares, all of one class, having a par value of \$100.00 per share.


