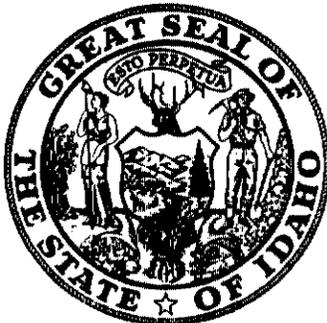
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

BJAN, INC.

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Bjan, Inc..

ARTICLE II

The corporation is to have perpetual existence.

ARTICLE III

The purpose for which said corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The capital stock of the Corporation shall be Fifty Thousand (50,000) shares of common stock, without par value. Twenty-Five Thousand (25,000) shares of said common stock shall be designated voting common stock and Twenty-Five (25,000) shares of said stock shall be designated nonvoting common stock. The capital stock of the Corporation shall not be assessable.

ARTICLE V

Provisions denying preemptive rights are: None

ARTICLE VI

The address of the Corporation's initial registered office shall be 2213 North 2000 East, Sugar City, Idaho 83448 and the name of its initial registered agent at such address is Berniece Summers.

ARTICLE VII

The number of directors constituting the initial board of directors of the Corporation is two (2) and the name and address of each person serving as a director until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:

ARTICLE IX

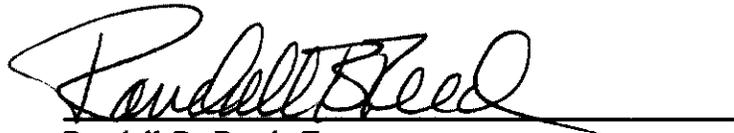
Provisions for the regulation of the internal affairs of the corporation are: None
