That said notice of said meeting was given in writing at the time and place of holding the meeting and of the intention to amend the Articles to all

stockholders in accordance with the laws of the State of Idaho and the Bylaws of the corporation. That at said meeting there were 135 members present, in person or by proxy, which number constituted a quorum as provided by the Bylaws of the corporation, more than two-thirds thereof voted to adopt the amendments. That the president of the corporation, presided at such meeting, and secretary of the corporation, acted as secretary.
