

ARTICLES OF INCORPORATION OF THE,
WYOMING-POSSIL-BASIN & IDAHO OIL COMPANY, LIMITED.

Know all men by these presents: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho. And we hereby certify:

I.

That the name of this corporation is Wyoming-Possil-Basin & Idaho Oil Company, Limited.

II.

That the purposes for which this corporation is formed are: For locating, purchasing, leasing and operating oil lands and properties, and all kinds of mineral lands, and mining properties, to drill oil wells, to maintain and operate pipe lines, tanks, reservoirs, refineries etc; to develop and operate all kinds of mines, mining properties, and mills or plants used in such business; said operations to be carried on in the States of Idaho and Wyoming; to lease, purchase, own, hold, and use all real or personal property, necessary or convenient, for the transaction of the business of said corporation, and for the carrying out of its purposes; to lease, mortgage, sell and convey, all the property, real or personal, belonging to the corporation, or any part thereof; to borrow money, and to secure the payment of the same by the execution and delivery of its bonds, or promissory notes, under its corporate name and seal, executed by its proper officers, and to secure the payment of said bonds, or notes, by executing and delivering, under its corporate name and seal, by its proper officers, a mortgage, or mortgages on all, or any part, of its property, real or personal, its franchise or corporate rights; said money obtained to be used in the carrying on of its said business, and enterprises; and in general to do all things necessary, and requisite, or incident, to the full and complete execution of all the herein named purposes, or that may properly appertain thereto.

III.

That the place where its principal business is to be transacted shall be the city of Boise, Ada County, State of Idaho.

IV.

That the term for which it is to exist is fifty (50) years from and after the date of its incorporation.

V.
