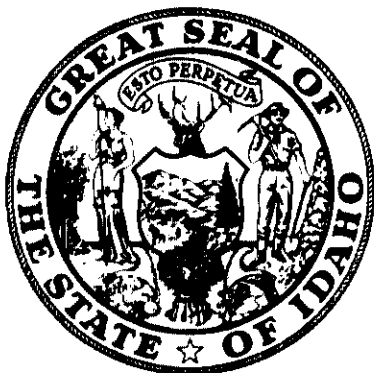

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being natural persons of legal age and acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is WCH RESEARCH CENTER, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The corporation is a non-profit corporation.

FOURTH:

The purpose or purposes for which the corporation is organized are: To conduct research regarding the operation of waste disposal systems and recycling of garbage and waste products.

FIFTH:

The corporation shall have at least three members. Any member shall also serve on the Board of Directors.

SIXTH:


