ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, Citizens of the United States of America, all over the age of 21 years, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we certify in writing:

Ι.

The name of the Corporation shall be IDAHO TIRE & SUPPLY,

II.

This corporation is formed for the following purposes; to engage in the business of handling tires and accessories of every kind and nature including the sale and servicing thereof; to buy and sell all types of supplies and merchandise that are incidental to the carrying on of such a business; to buy, lease or acquire the necessary land, buildings, equipment and materials for the carrying on of the business above mentioned; to enter into any other business that may be convenient and necessary for the general conduct of the corporation's success; to buy, sell, lease or construct buildings of every kind and nature; to borrow money and execute notes, mortgages or conveyances as security therefor; to buy and sell real estate as may be necessary in carry ing on the business of the corporation; to sell or purchase its own stock or to sell and purchase the corporate stock of any other corporation; to take, own and hold mortgages or other liens and generally to do all things necessary and convenient in carrying out the purposes for which this corporation is organized, and especially to exercise all of the rights and powers granted to general business corporations under the laws of the State of Idaho pretaining thereto at the date of the issuance of a certificate to these incorporators, and to exercise any or all powers and rights reinafter granted by the State of Idaho to general business corporations.

That the term for which said corporation is to exist is perpetual.

IV.

That the principal office and place of business for said corporation is Pocatello, County of Bannock, State of Idaho.

V.

That the number of directors of said corporation shall be not less than three and not more than seven as determined from time to time by either the shareholders or the board of directors.

VI.

That the total amount of the total authorized capital stock of this corporation is \$25,000.00, consisting of 250 shares of common stock at the par value of \$100.00 each.
